

NOTICE TO INDUSTRY SOD TYPE RESTRICTIONS EFFECTIVE IMMEDIATELY - 4/7/2025

Effective immediately, only Bahia sod is permitted for use within the area currently under irrigation restrictions in the Northeast section of Cape Coral. This restriction applies to the area bounded by:

- Gator Slough Canal to the North
- N.E. Pine Island Road to the South
- Nelson Road N to the West
- N.E. 24th Avenue to the East.

This restriction will remain in effect until further notice. Please refer to Exhibit 1 (attached map) for a visual representation of the affected area.

On June 1, 2024, Ordinance 46-23 took effect, establishing new irrigation restrictions in response to the region's rapid population growth and its impact on water supply, water quality, and long-term sustainability. The ordinance was enacted to enhance water conservation, increase efficiency, and reduce wasteful practices.

Despite these efforts, the current dry season has significantly strained local water resources due to increased usage and limited rainfall. With the South Florida Water Management District (SFWMD) expected to activate Phase 4 emergency irrigation restrictions, the City is taking proactive measures to preserve available resources.

To support these conservation efforts, the use of any sod other than Bahia is temporarily prohibited within the identified boundaries.



