

WATERWAYS

- a) The Public Works Department established a new Waterways Stakeholders Group on 10/1/25, nominating 12 members.
- b) Quarterly meetings scheduled for the first year, so far include two informational sessions on 10/20/25 and 11/3/25 on water quality, navigation, long-range planning and prioritization processes for dredging, aquatic vegetation harvesting, and public boat ramps' development and maintenance.

Information provided in previous quarterly updates:

- a) A final meeting with the previous stakeholders' group was held on 07/14/25. Two stakeholders out of 10 attended. New Organization and selection process presented.
- b) City advertised applications 7/15/25– 9/15/25 to fill positions. Meetings will take place in October and November with the new stakeholder group.
